Information Clause for the Person Whose Data is Being Processed within the Implementation of the Project titled "Your Second Home!" No. FEWM.09.03-IZ.00-0065/23

Due to your participation in the implementation of the Project, the provision of work, performance, provision, or delivery of works, services, or products within the Project/submission of an offer within the Project titled 'Your Second Home!' (project number FEWM.09.03-IZ.00-0065/23) under Priority 9 – Inclusion and Integration EFS+, within the regional program European Funds for Warmia and Mazury 2021-2027, based on Article 13 of the European Parliament and Council Regulation (EU) 2016/679 of April 27, 2016, on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (hereinafter: GDPR), I inform you that:

- 1. The controller of your personal data processed in connection with the implementation of the aforementioned Project is HN Partners Kamil Hałaczkiewicz Adrian Nowak Civil Partnership, the Beneficiary of this Project (hereinafter: the Beneficiary).
- 2. The Beneficiary has appointed a Data Protection Officer, with whom contact can be made via e-mail at: biuro@hnpartners.pl
- 3. Our personal data is processed based on Article 6(1)(c) and Article 9 of the GDPR. This means that your personal data is necessary for the Beneficiary to fulfill its legal obligations in connection with the implementation of the aforementioned Project. The legal obligations of the Beneficiary in connection with the implementation of the aforementioned Project are specified in the Project Financing Agreement no. FEWM.09.03-IZ.00-0065/23 and regulations, including those in the legal acts listed below:
 - Regulation (EU) 2021/1060 of the European Parliament and of the Council of 24 June 2021 establishing common provisions for the European Regional Development Fund, the European Social Fund Plus, the Cohesion Fund, the Just Transition Fund, and the European Maritime, Fisheries and Aquaculture Fund, as well as financial rules for these funds and for the Asylum, Migration and Integration Fund, the Internal Security Fund, and the Border Management and Visa Instrument.
 - Regulation (EU) 2021/1057 of the European Parliament and of the Council of 24 June 2021 establishing the European Social Fund Plus (ESF+) and repealing Regulation (EU) No. 1296/2013.
 - 3) Act of 28 April 2022 on the principles of implementing tasks financed with European funds in the 2021-2027 financial perspective (hereinafter: the implementing act).
- 4. Your personal data will be processed solely for the purpose of fulfilling the obligations of the Beneficiary, as specified by law and the Grant Agreement for the Project No. FEWM.09.03-IZ.00-0065/23-00, in relation to the implementation of the Project No. FEWM.09.03-IZ.00-0065/23 titled "Your Second Home!".
- 5. Your personal data, in accordance with applicable legal provisions, will be made available to authorized entities and institutions, including those specified in Article 89 of the implementing act, in particular:

- To the Managing Authority of the regional program European Funds for Warmia and Mazury 2021-2027 – Board of the Warmian-Masurian Voivodeship, Emilii Plater Street 1, 10-562 Olsztyn.
- To the Intermediate Body of the regional program European Funds for Warmia and Mazury 2021-2027 – Warmian-Masurian Voivodeship Labor Office in Olsztyn, Głowackiego Street 28, 10-448 Olsztyn.
- 5) To the Intermediate Body of the regional program European Funds for Warmia and Mazury 2021-2027 Warmian-Masurian Agency for Regional Development in Olsztyn, General Józef Bema Square 3, 10-516 Olsztyn.
- 6) To the Auditing Institution Head of the National Revenue Administration, Świętokrzyska Street 12, 00-916 Warsaw, to the extent necessary to carry out their tasks resulting from the provisions of this Act, and your personal data have been entrusted for processing or made available to entities (if applicable) participating in the implementation of the Project on behalf of the Beneficiary.
- 6. Your personal data may also be entrusted or disclosed to specialized entities conducting evaluation studies, inspections, and audits under the regional program European Funds for Warmia and Mazury 2021-2027, particularly at the request of the Managing Authority of the European Funds for Warmia and Mazury 2021-2027 regional program or the Beneficiary.
- 7. Your personal data will not be transferred to a third country or an international organization.
- 8. Your personal data will not be subjected to automated decision-making.
- 9. Your personal data will be stored for the period necessary to achieve the purposes specified in Article 87(1) of the Implementation Act.
- 10. At any time, you have the right to access your personal data and request its rectification. Furthermore, the right to erasure, the right to restrict processing, the right to data portability, and the right to object apply in cases and under the conditions specified in Articles 17-22 of the GDPR.
- 11. If you believe that the processing of your personal data violates data protection regulations, you have the right to lodge a complaint with the supervisory authority, i.e., the President of the Personal Data Protection Office, ul. Stawki 2, 00-193 Warsaw.
- 12. Providing your personal data is voluntary; however, refusal to provide it will result in the inability to participate in the implementation of the Project.
