



Mandatory criteria defining membership in the target group:				

a) is aged 15 to 89 years and: performs work for which they receive remuneration, derives profits or family benefits from it;

b) has employment or owns a business but is temporarily not working (due to, e.g., illness, leave, labor dispute, or education/training); or

c) produces agricultural goods, the main part of which is intended for sale or barter.

The following are also considered employed persons:

a) persons running their own business, i.e., conducting economic activity or activity referred to in Article 5 of the Act of March 6, 2018 – Entrepreneur's Law (Journal of Laws 2023, item 221, as amended), agricultural holdings, or professional practice, provided one of the following conditions is met:

i) the person works in their business, professional practice, or agricultural holding to earn income, even if the enterprise does not make a profit;

ii) the person devotes time to running the business, activity referred to in Article 5 of the Entrepreneur's Law, professional practice, or agricultural holding, even if no sales or services have been realized and nothing has been produced (for example: a farmer performing work to maintain their farm; an architect spending time waiting for clients in their office; a fisherman repairing a boat or fishing nets in order to continue working; persons participating in conferences, conventions, or seminars);

iii) the person is in the process of setting up a business, agricultural holding, or professional practice; this includes purchasing or installing equipment, ordering goods in preparation for launching the business.

A family member who helps without pay is considered employed if their work directly contributes to the economic activity, agricultural holding, or professional practice owned or run by a related member of the same household;

b) a family member who helps without pay a person running a business, who is recognized as a "self-employed person";

c) persons on maternity/parental/childcare leave, as referred to in the Act of June 26, 1974 – Labor Code (Journal of Laws 2023, item 1465), unless they are already registered as unemployed (in which case the unemployed status takes precedence);

d) students who are employed or run a business;

e) persons referred to subsidized employment.


⁹ An unemployed person is a person who is out of work, ready to take up a job, and actively seeking employment. This definition includes all persons registered as unemployed according to the national definition, even if they do not meet all three criteria mentioned above. Persons eligible for maternity or parental leave who are unemployed under this definition (i.e., not receiving benefits related to the leave) should also be classified as unemployed.

Active job seekers are persons registered with the employment office as unemployed or seeking work, or those not registered but meeting the above criteria — that is, ready to work and actively looking for employment.

- ¹⁰ An unemployed person registered at the local employment office (PUP) for over 12 months within the last 2 years, excluding periods of internships and adult vocational training.
- ¹¹ **Economically inactive person** a person who at the given moment is not part of the labor force (i.e., is neither employed nor unemployed). Economically inactive persons include, among others:
- a) full-time students, unless they are already employed (including part-time), in which case they should be classified as employed; b) children and youth under 18 years of age who are in education, provided they do not meet the criteria to be classified as
- c) doctoral candidates who are not employed at a university, other institution, or enterprise. If a doctoral candidate performs official duties for which they receive remuneration or runs a business, they should be considered employed. If the doctoral candidate is registered as unemployed, they should be counted among the unemployed.








I, the undersigned, declare my participation in the project "Common Future!" and hereby state that:
