



Participant's Statement of Consent to the Processing of Personal Data within the "Wspólna Przyszłość!" Project

Fulfilling the information obligation as required by Articles 13 and 14 of the Regulation (EU) 2016/679 of the European Parliament and Council of April 27, 2016, on the protection of natural persons regarding the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), I have been informed that:

1. The data controller will be:

The project beneficiary - HN Partners Kamil Hańczkiewicz Adrian Nowak Civil Partnership, with its registered office in Łódź, Targowa 27 (90-043).

2. The data controller processes your personal data based on the consent granted.

3. The data controller is committed to maintaining the confidentiality of personal data and information regarding the methods used to secure it.

4. The data controller declares that appropriate technical and organizational measures have been implemented to ensure an adequate level of security corresponding to the risks associated with the processing of personal data, as referred to in Article 32 of the GDPR.

5. The recipients of personal data will only be entities authorized to receive personal data. Any processing entity involved in the project will be obliged to protect personal data (according to Article 28 of the GDPR), and in particular, will ensure the implementation of appropriate technical and organizational measures to ensure that the processing meets the GDPR requirements.

6. Personal data may be transferred to other authorities and entities solely on the basis of applicable legal provisions, including entities involved in the project's implementation - the Intermediate Body (Voivodeship Labour Office in Warsaw, Młynarska 16, 01-205, Warsaw), the Managing Authority (Mazovian Voivodeship Board, Jagiellońska 26, 00-926, Warsaw), as well as entities conducting evaluation studies on behalf of the Managing Authority or entities conducting audits and controls on behalf of the Managing Authority under the program "European Funds for Mazovia 2021-2027."

7. Only persons who have been granted an individual authorization to process personal data in connection with the implementation of the project will be allowed to process personal data, and such authorizations will be issued after these individuals have been acquainted with the personal data protection regulations.

8 The personal data of the Candidate will be processed:



- a) for the purpose of conducting the recruitment of participants for the "Common Future!" project,
- b) for the purpose of fulfilling a legal obligation imposed on the Data Controller as defined in the Act of April 28, 2022, on the rules for the implementation of programs in the area of cohesion policy financed in the 2021-2027 financial perspective (Journal of Laws 2022, item 1079) and the Guidelines for monitoring the progress of the implementation of programs for 2021-2027,
- c) for the purpose of performing the contract concluded with the Data Controller.

9 The data will also be transferred to the SM EFS (the central teleinformatics system for monitoring entities and participants receiving support within projects financed from the European Social Fund Plus for the 2021-2027 financial perspective), managed by the Minister responsible for regional development. Refusal to provide data is equivalent to the inability to receive support under the Project.

10 Personal data will be stored until the completion and settlement of the project, as well as the closure and settlement of the "European Funds for Mazovia 2021-2027" Program, and until the end of the project's sustainability period and the archiving period, whichever occurs later.

11 The Candidate has the right to request from the Data Controller access to their personal data, its rectification, deletion, or restriction of processing. Requesting the deletion of data is equivalent to withdrawing from participation in the recruitment process conducted by the Project Organizer. Furthermore, the Candidate has the right to request the restriction of processing in cases specified in Article 18 of the GDPR.

12 Providing personal data is voluntary; however, refusal to provide data may result in the Candidate not being admitted to the project, except for sensitive data (disability and belonging to national and ethnic minorities), as referred to in Article 9 of Regulation (EU) 2016/679.

14 My personal data will not be processed in an automated manner and will not be subject to profiling.

15 My personal data will not be transferred to a third country or an international organization.

16 I have the right to lodge a complaint with the President of the Personal Data Protection Office regarding the unlawful processing of my personal data. However, the right to lodge a complaint relates solely to the lawfulness of personal data processing and does not cover the recruitment process.
